RELEASE, WAIVER OF LIABILITY AND COVENANT NOT TO SUE

In registering my minor child for the Program or Activity listed above ("Program"), and in consideration of FieldHouse Sports, Inc.'s agreement to allow my minor child to enter upon and use its playing field areas, and participate in any activity of any nature conducted thereon, including the Program or Activity listed above, I agree to the following:

1. I understand that there are inherent risks involved with my child's participation in the Program, including a risk of personal injury to my child, or others (such as family members or friends) observing the Program or on the FieldHouse Sports' premises to drop off or pick up my child, property damage, and in rare circumstances even death. I acknowledge and understand that because FieldHouse Sports, Inc.'s premises are open for use by other individuals, that my child and/or anyone accompanying my child at the Program is at a risk of contracting COVID-19 and/or other communicable illnesses. With full awareness of the risks involved, I for myself and on behalf of my child, family, spouse, estate, heirs, executors, administrators, and assigns forever release, waive, discharge and covenant not to sue FieldHouse Sports, Inc. and its employees, agents, servants, officers, directors, volunteers, and members (collectively "Released Parties"), from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, that may be sustained by my child, whether caused by the negligence of the Released Parties, or any third parties using FieldHouse Sports, Inc.'s premises, tools, equipment, or materials.

I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all costs, expenses, damages, claims, lawsuits, judgements, losses, and/or liability (including attorney fees) arising either directly or indirectly from or related to all claims made by or against any of the Released Parties due to bodily injury, death, loss of use, monetary loss, or any other injury from or related to my child's participation in the Program and/or use of FieldHouse Sports Inc.'s facilities, tools, equipment, or materials, whether caused by the negligence of the Released Parties or otherwise specifically related to COVID-19, or other communicable diseases.

I agree, further, that my minor child will conduct himself/herself at all times in accordance with the policies, rules and regulations of FieldHouse Sports, Inc., and acknowledge that the privilege of being upon said premises and/or participation in the Program may be revoked if said policies, rules, or regulations are not honored at all times, and all fees for the Program forfeited.
